As all TFGON Members know, we do not charge any dues or fees for membership, instead depending upon voluntary donations of our members to fund the organization and all our activities. Our Quarterly Networking Receptions are priced to be self-sustaining, but all our other activities, including the TFGON website, accounting, tax returns, the Members Directory, the Corporation/Organization Contact List, the Admiral McGrail Scholars Military Veterans Internship Program, administration of the TSA PreCheck airport security program for retired flag and general officers, and all TFGON's administrative expenses depend on voluntary membership donations every June and December. Suggested Language for Making a Bequest to TFGON in your Will!!!

You may include a bequest to support TFGON when preparing your will or by adding a codicil to your present will. The process is purposely quite simple and easy to accomplish. Bequests may be cash, securities, real estate or other property. Bequests of all sizes are welcome, whether they are outright, contingent, or residual, as they will ensure that support for your fellow Flag and General Officers and TFGON will continue in perpetuity.

If you are considering designating how your bequest will be used by TFGON or establishing an endowed fund through your estate plans, please contact TFGON [or have your professional advisor contact us] at TFGONAdmin@TFGON.org and put TFGON Endowment in the subject line.

Note: This information is not intended to be legal or tax advice. We recommend that you consult with a qualified estate planning attorney when drafting your will.

Your bequest should be directed to The Flag & General Officers' Network, Inc. TFGON is an IRS authorized tax deductible 501.c.19 official War Veterans organization---full details on the TFGON website at www.TFGON.org

The following language may be useful for your attorney:

Specific Bequest:

"I give The Flag & General Officers' Network, Inc., Alexandria, VA 22310, the sum of \$_____ to be used for the general support of TFGON, Inc."

Residual Bequest:

"I give The Flag & General Officers' Network, Inc., Alexandria, VA 22310, ___ percent of the residue of my estate to be used for the general support of TFGON, Inc."

Contingent Bequest:

"In the event that _____ predeceases me, I give The Flag & General Officers' Network, Alexandria, VA 22310, the sum of \$_____ [or, alternatively, ___ percent of the residue of my estate] to be used for the general support of TFGON, Inc."
